The World Council for Curriculum and Instruction has published the article of Sr. Ma. Evangeline L. Anastacio, SPC, **Balanced scorecard model for Paulinian educational institutions**, in *The International Journal for Curriculum and Instruction*.

Following is the abstract of Sr. Evangeline's article:



The researcher aimed to come up with a mission-centered strategic management system for Paulinian schools using the Balanced Scorecard (BSC) approach. To achieve this project, a consensus was derived from 39 schools in the Philippines run by the Sisters of St. Paul of Chartres (SPC) using the Delphi technique. The resulting BSC model included five perspectives, namely, spirituality, internal processes, learner and external community, learning organization, and fiscal resources perspectives. Strategic objectives with the corresponding key performance indicators (KPIs) were identified. Unique to the resulting BSC model is the inclusion of spirituality perspective which ensures the conscious infusion of long-lasting values in all aspects of the school.

The SPU Manila community congratulates Sr. Evangeline on this publication in a prestigious international journal.

SPU MANILA GRANTED AUTONOMOUS AND DEREGULATED STATUS

As mentioned in a previous *Inter-Office Bulletin*, SPU Manila was again given Autonomous University Status by the Commission on Higher Education (CHED).

By virtue of CMO No. 20, Series of 2016, the status is effective 1 April 2016 to 31 May 2018.

Autonomous and deregulated status is granted by the Commission on Higher Education (CHED) to Higher Educational Institutions (HEIs) based on the following criteria: long tradition of integrity, and untarnished reputation; commitment to excellence; and sustainability and viability of operations.



On 16 May 2016, Sr. Ma. Evangeline L. Anastacio, SPC and other SPU Manila administrators, Dr. Rhoda Reyes and Dr... Marichen Dychangco, outgoing and incoming Vice Presidents for Academics, went to the CHED Auditorium to receive the award, together with representatives of other autonomous and deregulated HEI's.

Among the benefits to be enjoyed by private higher education institutions granted autonomy are the following:

1. Exemption from the issuance of Special Order (S. O.).
2. Free from monitoring and evaluation activities of the CHED. However, identified PHEIs shall submit requested data as part of the data gathering activity of CHED for it's MIS.
3. Entitlement to grant of subsidies and other financial incentives assistance from the Commission on Higher Education, whenever funds are available
4. Privilege to determine and prescribe their curricular programs to achieve global competence.
5. Privilege to offer a new course/program in the undergraduate/graduate level/s without securing permit/ authority from the CHED. However, the higher education institution must inform the CHED Regional Office concerned of the new course/program to be offered.
6. Privilege to established branch /es or satellite campus/es without the prior approval of the CHED, but with information to the CHED -Regional office where the new branch/campus is to be
